#### 3 FALSE MYTHS TO DEBUNK IN THE PROFESSIONAL CLEANING


Not just succulent dishes.

In a professional kitchen you may see everything, especially in terms of cleaning and hygiene.

Bad habits reign supreme and often wrong methods are adopted unknowingly, completely opposed to those that should be undertaken.

At the origin of these incorrect procedures, we find mostly false beliefs, based on word-of-mouth and ignorance due essentially to a lack of training.

However, how to recognize what the cleaning operators are wrong believing and therefore doing? Below, the **top 3 by Allegrini**: the biggest false myths encountered by his team of experts, following the inspections carried out in dozens of professional kitchens.





Nothing could be more wrong: the ideal product to eliminate the most tenacious greasy dirt is not an acidic product, but a highly alkaline detergent. The formulation based on surfactants with high degreasing power and high wetting effect is the most suitable to efficaciously remove the dried and encrusted grease on cooking plates, ovens, stoves, toaster and sandwich heaters. On the contrary, an acid product is highly recommended to remove calcareous deposits from fittings.

#### 3 FALSE MYTHS TO DEBUNK IN THE PROFESSIONAL CLEANING

### #2 - I need a product that contains bleach to well clean the floors.

Almost by osmosis, bleach has entered the minds of cleaning operators as the only one capable of cleaning and whitening in a single operation. In reality, the cleaning capacity of a cleaning product is given by the presence of surfactants that attack the dirt and effectively remove it from the surface.

The bleach does not have optimal properties to remove dirt: the white color of the tiles that we see after using it is due to the oxidizing and bleaching power of sodium hypochlorite, trivially considered chlorine. To properly clean the floors, a controlled foam detergent with high degreasing power is recommended, to be used with a scrubber machine: the result is a clean surface that returns to its original appearance, without risk of slipping.





### #3 - After washing up the floor, I wash the cloth and let it soak in a bucket with bleach.





"Why do not leave to the bucket the task of washing the cloth that I used to clean the ground?" It would make you laugh, but there are still those who do it: in the century of technological innovations, the most used practice by our grandmothers still remains: the soaking dirty cloth left in a bucket for hours and hours.

The microfibre cloth, the most suitable to remove the dirt from the floor, is thus destined for another bucket, that of the garbage. Yes, because if soaked in bleach, its fibers are burned making it unusable.

The solution? A cycle in the washing machine and the cloth will come back like new.
